The Charter Township of Waterford is seeking sealed bids for the "EECBG LED Lighting Improvements and Wind Energy Conversion Upgrades" project for our Public Works Department. Sealed bids are invited and will be received at the Township Hall, Clerks Office, 5200 Civic Center Drive, Waterford, MI. 48329 on or before, but not later than 2:00 PM, local time on Tuesday, August 31, 2010. All bids to be clearly marked on outside of envelope (EECBG LED Lighting Improvements and Wind Energy Conversion Upgrades, with your Company name). All bids received will be opened and read immediately in the auditorium of the Town Hall. Contract will be awarded at the September 13, 2010 Board Meeting.

The Work includes, but is not limited to the following:

1. Demolition and removal of existing exterior luminaries, lighting poles, feeders, concrete bases etc. no longer intended for re-use, as indicated on the contract documents.
2. Receive, handle, store, and install new exterior LED lighting assemblies including poles, luminaries, control boxes, pole base/foundations, etc.
3. Provision of feeders and grounding systems for complete operation of new lighting assemblies.
4. Installation of two (2) 1.2kW vertical axis wind turbines manufactured by Windspire and associated electrical system, including feeders, disconnect switches, circuit breakers, meters, etc., as indicated on the contract documents.
